MODEL RESOLUTION

INCLUSION OF CLERICAL AND OTHER PERSONNEL WHOSE SERVICES ARE AUXILIARY TO FIRE PROTECTION UNDER THE FPPA STATEWIDE DEFINED BENEFIT PLAN, STATEWIDE HYBRID PLAN OR THE STATEWIDE MONEY PURCHASE PLAN

(Note: The adopting entity should change “Employer” to the entity’s legal name and may adapt the model to follow its own format for resolutions.)

WHEREAS, Employer is a fire protection district, fire authority, or county improvement district providing fire protection services, duly constituted under Colorado law; and

WHEREAS, for the purposes of participation in the statewide defined benefit plan pursuant to part 4 of Title 31, Article 31, C.R.S., - the statewide money purchase plan pursuant to part 5 of Title 31, Article 31, C.R.S., or the statewide hybrid plan pursuant to part 11 of Title 31, Article 31, C.R.S. as operated by the Fire and Police Pension Association pursuant to Section 31-31-102(4) C.R.S., the definition of “Member” may include clerical or other personnel employed by a fire protection district, fire authority, or county improvement district, whose services are auxiliary to fire protection; and

WHEREAS, pursuant to Section 31-31-102(4) C.R.S., the definition of “Member” specifically excludes clerical or other personnel whose services are auxiliary to fire protection from participation in the statewide death and disability plan pursuant to part 8 of Title 31, Article 31, C.R.S.

INCLUDE THIS PARAGRAPH IF THE EMPLOYER’S FULL-TIME PAID FIREFIGHTERS CURRENTLY PARTICIPATE IN THE STATEWIDE DEFINED BENEFIT PLAN OR THE STATEWIDE HYBRID PLAN:

WHEREAS, Employer’s full time active employees whose duties are directly involved with the provision of fire protection are covered under the statewide defined benefit plan established pursuant to part 4 of Title 31, Article 31, C.R.S., or the statewide hybrid plan established pursuant to part 11 of Title 31, Article 31, C.R.S., and the statewide death and disability plan established pursuant to part 8 of Title 31, Article 31, C.R.S.:

IN ADDITION PLEASE INCLUDE ONE OF THE THREE OPTIONS BELOW

INCLUDE THIS PARAGRAPH IF IT IS THE EMPLOYER’S INTENTION TO ENROLL ONLY FULL-TIME CLERICAL AND OTHER PERSONNEL IN THE STATEWIDE DEFINED BENEFIT PLAN:

Employer desires to cover its clerical and other personnel working sixteen hundred hours or more per year under the statewide defined benefit plan established pursuant to part 4 of Title 31, Article 31, C.R.S. Employer acknowledges that said clerical and other

Employer desires to cover its clerical and other personnel working less than sixteen hundred hours per year under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31, C.R.S. Employer acknowledges that said clerical and other personnel are not eligible to participate in the statewide death and disability plan established pursuant to part 8 of Title 31, Article 31, C.R.S.; or

INCLUDE THIS PARAGRAPH IF IT IS THE EMPLOYER'S INTENTION TO ENROLL BOTH FULL-TIME AND PART-TIME CLERICAL AND OTHER PERSONNEL:

Employer desires to cover its clerical and other personnel working sixteen hundred hours or more per year under the statewide defined benefit plan established pursuant to part 4 of Title 31, Article 31, C.R.S. AND its clerical and other personnel working less than sixteen hundred hours per year under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31, C.R.S. . Employer acknowledges that said clerical and other personnel are not eligible to participate in the statewide death and disability plan established pursuant to part 8 of Title 31, Article 31, C.R.S.

INCLUDE THIS PARAGRAPH IF THE EMPLOYER'S FULL-TIME PAID FIREFIGHTERS CURRENTLY PARTICIPATE IN THE STATEWIDE MONEY PURCHASE PLAN:

WHEREAS, Employer's full time active employees whose duties are directly involved with the provision of fire protection are covered under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31 C.R.S., and the statewide death and disability plan established pursuant to part 8 of Title 31, Article 31, C.R.S. :

Employer desires to cover its clerical and other personnel working less than sixteen hundred hours per year under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31, C.R.S. Employer acknowledges that said clerical and other personnel are not eligible to participate in the statewide death and disability plan established pursuant to part 8 of Title 31, Article 31, C.R.S.; or

INCLUDE THIS PARAGRAPH IF IT IS THE EMPLOYER'S INTENTION TO ENROLL BOTH FULL-TIME AND PART-TIME CLERICAL AND OTHER PERSONNEL IN THE STATEWIDE MONEY PURCHASE PLAN:

Employer desires to cover its clerical and other personnel working sixteen hundred hours or more per year AND its clerical and other personnel working less than sixteen hundred hours per year under the statewide money purchase plan established pursuant to part 5 of Title 31, Article 31, C.R.S. Employer acknowledges that said clerical and other personnel are not eligible to participate in the statewide death and disability plan established pursuant to part 8 of Title 31, Article 31, C.R.S.

NOW THEREFORE BE IT RESOLVED by the Employer that:

1. Such election shall become effective on _____, 20__ (the first day of a pay period), assuming all necessary forms, procedures and other relevant paperwork is completed; and
2. The Employer's clerk or secretary is directed to file a certified copy of this resolution with the Fire and Police Pension Association as soon as practicable and Employer's staff is directed to take all other actions necessary to implement the coverage.
